Cllr Rowe explained that the Councils were given a chance to give feedback and all increases were as per this feedback.

Cllr Harriss asked whether Dartmouth and Totnes were being treated equally regarding charging for use of public toilets and carparking. Cllr Rowe responded that the towns were being treated equally.

A member of the public asked if DTC would consider asking BRNC to consider some land for social housing.

A member of the public asked Cllr Rowe why car parking was up to £6 for 4 hours, which is 50% more than Kingsbridge. Cllr Rowe answered that she would bring the information on car parking charges back to this council next month. She said that she would pass the executive report which publishes all the carparking figures to the Clerk.

Mr Mitchell said that Dartmouth is beginning to look very quiet and carparking was one of the reasons. The Mayor spoke about the loss of Little Cotton Caravan Park and how this will have had a knock on effect to footfall in the town, he said he would like to bring back a caravan park.

A member of the public asked how many Cllrs will be attending the meeting on Monday for hospital, Cllr Lyon then asked the Cllrs who would be attending and six Cllrs confirmed they would be attending the meeting.
