2. CORRESPONDENCE – GRANT APPLICATIONS

a) TIC – additional grant of £3,000

Members discussed the running costs of the Tourist Information Centre and it was noted that South Hams District Council charged rent of £6,000 for the building. Chris Brook at South Hams District Council had declined the Town Council's suggestion that they take over the ownership of the building.

b) <u>Devon Young Carers</u>

5. **BUDGET FOR 2016/2017**

Members reviewed a draft budget for 2016/2017. Professional advice would be sought on the clearing of mud from the Boatfloat.
