A member of the public asked what the Emergency Plan was and if there were any contingency plans for the upcoming lockdown for the residents of Dartmouth.

Cllr D Case replied that the Emergency Plan she was working on was regarding flooding and other risks with the Environment Agency. The plan was not specifically about a global pandemic, but this could be added in the future.

The same member of the public asked what the Council had planned with local agencies to work together over the second lockdown to ensure the comfort and safety of residents in Dartmouth.

Cllr G Webb replied that the Council would work with all the different charities and bodies in Dartmouth during the pandemic.

Cllr D Case said that on page two she had been in discussions with DALAG and other local groups and that starting a new group, as suggested by Cllr A Edsall was not part of the proposal.

Cllr D Case also asked for the proposal she shared to be added as an appendix to the minutes.

Cllr G Yardy asked if the 60 electric car charging points that have been proposed for the Health and Wellbeing Centre would be considered prior to the planning application approval that takes place in December.

Cllr J Hawkins replied that he had a meeting with the officer from DCC and that he had emailed SHDC but was waiting for a response. Cllr J Hawkins added that when the planning application came up that he would ensure that it was raised to the Planning Committee.

Cllr D Shepherd asked the District and County Cllrs what they thought of the Government's refusal to feed children during half-term.

Cllr J Hawkins replied that he clearly said in his report that he thought this was the wrong decision for the Government to make and that he had raised this issue with the local MP last week. Cllr J Hawkins hoped that the Government would change its opinion.

Cllr D Shepherd also asked where the Food Strategy Money, that was sent to DCC to help with the first COVID lockdown.

Cllr J Hawkins replied that the money was given by central Government and had to be spent by June 2020. DCC had put some more money in the pot to give to District Cllrs to assist with this.

Cllr R Rowe responded that she thought that the Government had made the wrong decision concerning free meals for children during the holidays. Cllr R Rowe added that this should also include food hampers for families that were struggling at this time and that she had also spoken to the local MP about this issue.

Cllr J Hawkins left the meeting at 19:18

Cllr G Yardy asked for the electric charging points provision for the whole of the South Hams to be looked.

Cllr D Shepherd asked that if a site could be found for the travelling Gypsy and Romany community in the area, which would mean that people would not be moved on. Cllr Shepherd asked if SHDC would work with her to secure that.

Cllr R Rowe replied that they would and that any information would be forwarded on to Cllr D Shepherd.

178. PRESENTATION FROM CLASSIC CHANNEL REGATTA COMMITTEE

The Classic Channel Regatta Committee gave a short presentation about the Regatta that takes place in Dartmouth every two years.

179. TO CONSIDER REPLACING THE TREE IN CORONATION PARK (INCLUDING PLAQUE) PLANTED BY THE QUEEN IN 1969 AND REMOVED DUE TO INFECTION (Cllr Webb)

Cllr D Case explained that Easyfundraising enabled members of the public to support DTC through the DTC Easyfundraising webpage. When a supporter buys something online, the retailer pays Easyfundraising a donation, generally 0.5% to 10% of the purchase. The shopper does not pay any more for their shopping and DTC receives money that can be used to help the community.

There was a short discussion about the idea of a DTC Easyfundraising page between the Councillors.

S.H.D.C. REPORT FOR OCTOBER 2020

The time has gone very quickly, and we have been under restrictions for 7 months now and with no end in sight. We seem to have more meetings etc. By Skype, Zoom etc. than ever. It is very easy as we do not have to leave home and can go from one meeting to another without having to drive anywhere.

This month has seen the upheaval of the refuse collection change of days etc. Some households have seen very little change except for day of the week collection. However, in some areas it has been total chaos. I do hope it will sort itself out within the next few weeks and will run smoothly. We will wait to see what happens when we get to the Super recycler Service which is starting next spring.

The refuse and dog poo bins in some areas have not been emptied much either despite being reported regularly both online and by phone.

The leisure centres have now all reopened from 14th October. Please use the South Hams Council Centres. Use them or we will lose them.

Work is in progress with the installation of Charging points for Electric Vehicles including points when the Car park is constructed at the Dartmouth H.& W. Centre.

The Council is working to endorse a strategy with D.C.C. to identify a Gypsy and Travellers site within the South Hams. South Hams does not have a permanent site which means that travellers etc. Must be continually moved on as we don't have anywhere for them to go.

The Council has secured £330,000 grant to help improve older homes energy efficiency .this is part of a plan to save householders money and to cut carbon emissions .This is known as the green Homes Grant Scheme and is accessible via email eco@swdevon.gov.uk

Chancellor's Economic Statement

On 22 October, the Chancellor made an economic update statement to the House of Commons. The press release is also attached.

This outlined three additional or extended areas of support:

- Job Support Scheme (JSS) – this replaces the current furlough arrangements: prior to implementation in November, this scheme has been extended in relation to employers which are open, but subject to reduced business. Employees will now only have to work 20% of their usual hours to be eligible for the scheme (this has changed from 33%), and the government will now pay 61.67% of the ‘unworked’ hours with the employer covering 5%. This means that the employee will receive full pay for hours worked and 66.67% for ‘unworked’ hours. In total, employees will therefore receive 73% of their wages up to £3,125 per month. - The Self Employment Income Support Scheme (SEISS) has also been extended to cover 40% of monthly trading profits, up from 20% previously announced. The Self-Employment Income Support Scheme Grant Extension provides critical support to the self-employed in the form of two grants, each available for three month periods covering November 2020 to January 2021 and February 2021 to April 21.

The first grant will cover a three-month period from 1 November 2020 until 31 January 2021. The Government will provide a taxable grant covering 40% of average monthly trading profits, paid out in a single instalment covering 3 months’ worth of profits, and capped at £3,750 in total.

The Government are providing broadly the same level of support for the self-employed as is being provided for employees through the Job Support scheme.

The second grant will cover a three-month period from 1 February 2021 until 30 April 2021. The Government will review the level of the second grant and set this in due course. Full details of the SEISS are available here.

- The Local Restrictions Support Grant (Business Grants) have also been extended. This will now offer grants to businesses closed as a result of national as well as local measures, and to businesses in Tier 2 areas. Tier 2 grants of up to £2,100 per month of restrictions (applied retrospectively) will be available for distribution at the discretion of local authorities, who will receive enough funding to cover every premise in hospitality, leisure and accommodation (The amount is dependent on the Rateable Value of the business as there is a lower amount for businesses under a Rateable Value of £51,000). Businesses in any area which has been under enhanced restrictions can backdate grants to August. Below is an extract of a Government document:

- We are providing additional funding to allow Local Authorities (LAs) to support businesses in high-alert level areas which are not legally closed, but which are severely

impacted by the restrictions on socialising. The funding LAs will receive will be based on the number of hospitality, hotel, B&B, and leisure businesses in their area.

- LAs will receive a funding amount that will be the equivalent of:
- For properties with a rateable value of £15,000 or under, grants of £934 per month.
- For properties with a rateable value over £15,000 and below £51,000, grants of £1,400 per month.
- For properties with a rateable value of exactly £51,000 and over, grants of £2,100 per month.
- This is equivalent to 70% of the grant amounts given to legally closed businesses (worth up to £3,000/month).
- Local Authorities will also receive a 5% top up amount to these implied grant amounts to cover other businesses that might be affected by the local restrictions, but which do not neatly fit into these categories.
- It will be up to Local Authorities to determine which businesses are eligible for grant funding in their local areas, and what precise funding to allocate to each business – the above levels are an approximate guide.
- Businesses in Very High alert level areas will qualify for greater support whether closed (up to £3,000/month) or open. In the latter case support is being provided through business support packages provided to Local Authorities as they move into the alert level. The government is working with local leaders to ensure the Alert Level very high packages are fair and transparent.

The 5% to be used as discretionary grant funding is to support businesses which are closed but are not in the business rating system as well as businesses that may not be required to close but which are severely impacted (e.g. because of closure of their suppliers or the customers they supply to). The existing scheme guidance is here, (though this has not yet been updated for the new amounts in the Chancellor's statement yesterday).

Job Retention Bonus

Employers can claim the bonus for all eligible employees who have been furloughed. This will see businesses receive a one-off payment of £1,000 for every previously furloughed employee if they are still employed at the end of January next year.

Track and Trace Hardship payments

This is a new Government support scheme, whereby Track and Trace Payments Hardship payments of £500 have been introduced by Central Government to help people on low incomes who will be financially impacted when they are required to self-isolate.

These payments have to be administered by Local Authorities and the Council had to put a scheme in place very quickly, as the scheme had to be ready to process payments by 12th October 2020. Members considered a report on this this week.

The report set out the criteria that an individual would need to meet to qualify for the £500 payment. This discretionary payment is for individuals who are not currently receiving Universal Credit, Working Tax Credit, income-related Employment and Support Allowance, income-based Jobseeker's Allowance, Income Support, Housing Benefit or Pension Credit; and who are on low incomes and will face financial hardship as a result of not being able to work while they are self-isolating.

Support for Councils

1) Contain Outbreak Management fund – The Government has announced this fund to help Councils carry out our responsibilities.

This is a Department of Health and Social Care fund to help us carry out our responsibilities. We would be eligible for a £1 per head of population payment being in the Medium Alert Level. If we moved to a High level the £1 is increased to £3 per person, and is increased to £8 per person for Very High areas. Funding is one-off and paid to DCC to distribute.

Following the move to Local COVID Alert Levels, and as of 12 October 2020, Local Authorities will be eligible for a series of payments from the Contain Outbreak Management Fund to support proactive containment and intervention measures:

1. A payment of up to £1 per head of population will be provided to Local Authorities in Local COVID Alert Level Medium (This applies to our Council). This will be disbursed as soon as public health activities have been agreed with the relevant Regional Convenor.
2. Where Local Authorities move to Local COVID Alert Level High or Very High this financial support will automatically be increased to £3 per person and £8 per person respectively.
3. This funding is incremental, not additional.
4. Funding is one-off. Repeated movement between Local Alert Levels will not enable reoccurring support from this fund.
5. Funding will be paid to Upper Tier Local Authorities (Devon County Council), for onwards disbursement.

Financial support for Local Authorities at Local COVID Alert Level Medium and High is to fund the following activities:

- a. Targeted testing for hard-to-reach groups out of scope of other testing programmes.
- b. Additional contact tracing.
- c. Enhanced communication and marketing e.g. towards hard-to-reach groups and other localised messaging.
- d. Delivery of essentials for those in self-isolation.

e. Targeted interventions for specific sections of the local community and workplaces.

f. Harnessing capacity within local sectors (voluntary, academic, commercial).

g. Extension/introduction of specialist support (behavioural science, bespoke comms).

h. Additional resource for compliance with, and enforcement of, restrictions and guidance

We have no plans to use this funding at this time and our strategy is to see how the 2nd wave develops before committing to further expenditure.

2) Local authority compliance and enforcement grant – Covid Compliance Officers

Under this new grant initiative, SHDC have been allocated £34,522 and WDBC have been allocated £25,512 of Government funding.

We are recruiting two Covid Compliance Officers roles for 6 months covering both Councils. These posts will support the work of the EHO's in enforcing Covid Secure guidelines in business premises. The ethos will be 'helping businesses to comply' and therefore helping to protect our communities by;

- Reducing demand by working proactively and educating businesses
- Providing customer focused specialist advice and promoting the work of the Councils and their reputation
- Providing practical support to aid and encourage compliance
- To deal with a range of COVID-19 compliance issues
- To assist in taking enforcement action of COVID-19 regulations or guidance where necessary

3) Devon County Council funding – Vulnerability Officer

Devon County Council pledged £1million in the summer to support the most vulnerable households affected by Covid-19. This was through a variety of interventions including money advice, hardship payments and support to families delivered through our local schools. It has continued to compliment a range of support the Council is able to offer, such as discretionary housing payments, housing benefits etc. Recognising that the demand is going to continue for these kinds of support, the Districts requested that some of the money be made available for physical posts which Devon County Council has agreed.

A Vulnerability Officer (a shared post across South Hams and West Devon) will work with our partners on interventions and internally to ensure all available support is accessed and any action (debt recovery for example) is proportionate and a last option. It will help to ensure funding goes further, by identifying repeat cases and considering underlying issues and will be a 'go to' officer for all services within the Council, including Members.

District Council's Hopes For Improved Home Insulation

As part of its drive to be carbon neutral by 2050, South Hams District Council is recommending committing over £500,000 to improve the energy efficiency of households within the District.

A successful Council bid for The Department for Business, Energy and Industrial Strategy (BEIS) funds, through the Green Homes Grant Scheme, has secured over £330,000 to help improve older homes' energy efficiency as part of a plan to save households money and to cut carbon emissions.

The Council is now proposing to commit a further £200,000 specifically targeted at low-income families living in fuel poverty and to underline its commitment to do it all can to tackle the global climate change and biodiversity challenges.

A Green Homes report going to the Executive Committee, on Thursday 22 October, recommends that whilst the majority of the Council's reserves are kept under review during the uncertainty around the pandemic, it is prudent to release £20k from the Climate Change and Biodiversity Earmark Reserve. This is to support delivery of these schemes and help some of the most vulnerable in our community.

In line with the Council's emerging Climate Change and Biodiversity Strategy, the extra funding, if agreed, will also help to reduce carbon emissions from existing housing, which remain a major source of CO2 emissions in the District.

The Green Homes Grant project will focus on the installation of external wall insulation and air source heat pumps for eligible households.

This scheme would mean properties, which are not on the mains gas supply and rely on alternative, less efficient sources of heating, such as oil and solid fuel, would benefit from these improvements early next year.

Whilst the additional funding, if given the green light, will help secure further reductions in fuel poverty and carbon emissions through a range of different interventions and by leveraging in additional funds.

South Hams District Council's Leader, Cllr Judy Pearce, said: "I'm delighted that we have been able to secure crucial funds to improve energy efficiency in homes, and to support some of our most vulnerable households while underlining our commitment to the Climate Change and Biodiversity Emergency.

"With recent information forthcoming from Government on local authorities' funding for the coming year, we are now able to go the extra mile by recommending further funding from our reserves to deliver this vital project and to provide extra officer time in looking at further ways to help carbon reduction.

"This is an important step in reducing the District's carbon footprint in homes which don't currently benefit from efficient insulation or use inefficient methods of heating."

A member of South Hams District Council's Climate Change and Biodiversity Working Group, and Leader of the Council's Green Party, Cllr Jacqi Hodgson, added: "It is so very important that we tackle this particular carbon issue with these very welcome new funds that have become available to us. It is very timely as the winter chill sets in and we provide a low carbon alternative to turning up carbon heavy thermostats.

"Insulating homes and providing more efficient, renewable sources of heating can result in energy savings of between 10 - 30% and the installation of air source heat pumps and external wall and roof insulation will go a long way towards this. I'm very positive that additional resource has been allocated to support this incredibly important work."

This will be a sum of either £1000 or £1500 (dependent on the rateable value) that will be payable every three weeks that an area is subject to a local lockdown.

The government has provided us with guidance (although this is subject to change) as to how we will support businesses affected by a local lockdown. Whilst part of the scheme is mandatory, there is another part that is discretionary, so, just as we did with Track & Trace, we are looking for the Chief Executive to once again exercise his urgent powers in order for us to go live quickly.

Whilst we have had some guidance, we do not yet know our discretionary element funding so once we now more we will be able to update Members further.

'Super-fast' Electric Vehicle chargers unveiled for public use

Cutting-edge 'rapid' Electric Vehicle (EV) charge points have now been commissioned for public use at three council car parks in South Hams and Teignbridge.

From this week EV users can charge their electric vehicles at Ivybridge's Glanvilles Mill car park, the Chudleigh Library car park and at Buckfastleigh's Mardle Way car park.

The £175,000 project is a partnership of Devon County Council (DCC), South Hams District Council and Teignbridge District Council has been made possible by funding from Highways England.

The 'rapid' charge points are among the fastest chargers available - EVs should have an 80 per cent charge within 30 minutes, and will be operated by SWARCO and compatible with all EVs currently on the market.

This scheme is the latest example of Highways England's Designated Funding programme assisting local authorities to improve air quality across the country, helping DCC and district councils to work together to deliver EV charging points along the A38 in Devon.

Currently DCC and the district councils are working to deliver the government-funded Deletti project, the first phase of which aims to deliver at least 25 charging points in public carparks across the county from early next year.

And DCC is working with the private sector on the government-funded 'Street Hubz' project which aims to deliver at least 100 on-street EV charging points in Exeter from next year.

All three projects are part of local authority efforts to help reduce carbon emissions in Devon.

Last year DCC declared a 'climate emergency' and formed the Devon Climate Emergency Response Group (DCERG).

The DCERG is a group of 25 influential business groups, public sector bodies and councils - including South Hams District Council, Devon County Council and Teignbridge District Council.

They are working together to reduce carbon emissions and create a Devon Carbon Plan – a road map to carbon neutrality.

South Hams District Council's Portfolio Holder for the Environment, Cllr Keith Baldry, said: "It's really important to us to deliver as many electric vehicle charging points across the District as quickly as we can. The charging points in Ivybridge are a good starting point towards us reducing our carbon footprint. They are perfect for the town but also for travellers on the nearby A38 corridor. We are committed to our Climate Change and Biodiversity Plan and have already started to change over some of our fleet to electric vehicles."

Councillor Stuart Hughes, Devon County Council's Cabinet Member for Highways Management, said: "I recognise the difficulty in encouraging more people to use electric cars until there are more charging points and that's why we are working closely with our district and government partners to deliver charge points in prime locations such as this. "While the government has committed to banning the sale of all new petrol and diesel cars and vans from 2040, we want more people to start using electric vehicles long before that. Fewer petrol and diesel cars will lead to a reduction in emissions, cleaner air and an improved quality of life for all residents."

Highways England Project Sponsor Brian Cull said: "We're pleased to be working with councils across the country to make more provision for drivers making the switch to electric, and over 95% of England's motorways and major A-roads are now within 20 miles of an electric vehicle charging point.

"The charging points will help drivers of electric vehicles make longer, cleaner journeys and reduce the anxiety of potentially running out of power.

"Elsewhere in the South West, we have already funded charging points along the A303 in Somerset, and this is another example of how we are using designated funding to benefit the environment and communities alongside our roads, as well as the people travelling and working on them."

Councillor Jackie Hook, Teignbridge District Council's Executive Member for Climate Change, said: "These two EV charging sites in Teignbridge mark a major milestone in our commitment to move to a more sustainable mode of transport, and we're grateful to our partners at Devon County Council and Highways England for their contribution to this. Use of electric vehicles will be part of the solution to a cleaner, greener and more sustainable future, alongside increased use of cycling and walking, and better public transport links. We want to promote the use of all these modes of transport through improved facilities and increased safety, to give our residents more ways to reduce their carbon footprint."

South Hams District and West Devon Borough Councils Remove the RingGo App Fee

From 12th October, the convenience fee charged across South Hams and West Devon car parks when purchasing parking tickets through the RingGo app will be removed. This brings charges in line with tickets purchased at the meters. South Hams District and West Devon Borough Councils hope this will encourage even more motorists to pay to park via the RingGo app.

The Councils have seen a significant increase in contactless parking payments over recent months with visitors taking advantage of the RingGo app to pay for parking in an easy, touch-free way. New figures show that more drivers have been using RingGo than ever before, when parking in Council owned car parks. On average, Councils across the South West have seen the number of parking sessions in July and August double compared to the number of registered transactions during the same months last year.

The use of the RingGo app through the COVID-19 pandemic has allowed the public to pay for parking without needing to use a Pay and Display machine. Thereby eliminating the need to encounter multiple touchpoints and interact with others when standing in queues. Cllr Keith Baldry, Executive Member for Environment at South Hams District Council, said: "In the current climate, paying touch-free has become increasingly important. Since most people carry a smart phone these days, paying through the RingGo app is very convenient for consumers and this is shown through the increase in payments via the app this summer. "It means that drivers no longer need to queue or handle cash to pay for their parking. During the pandemic, touch-free parking is even more important as it reduces the risk of transferring the virus."

Cllr Terry Pearce, Lead Member for Communities at West Devon Borough Council, said: "RingGo has always been a convenient way of parking because you can quickly and easily extend your stay without the need to go back to the car park to add more money to a machine. It is even better now because we have removed the convenience charge, thereby giving a financial saving to the user in these difficult times.

"This means it costs the same to park whether you pay by cash or through the app. If you have a smartphone, it is also a safer method of paying, because you can pay on your own device without the need to touch the machine at all."

The Councils and RingGo have been working closely in the past months to ensure the needs of motorists are being addressed in this current climate. RingGo has been providing tailored signage and social imagery, adjusting app experiences, increasing usage of cashless options and even helping with removal of parking machines in some areas. In each of these cases, both parties worked together to establish the best solution for that area and implement it swiftly.

Test and Trace Support Grant

If you are required by law to self-isolate because you have been in close contact with someone who has COVID- 19, and you are on a low income, you may be supported through a payment of £500, which would be administered by your local Council.

For people who are facing hardship because they have been contacted by NHS Track and Trace and are required to self-isolate for 14 days, the Government has launched a grant to support scheme.

If you are working, and on a low income, and are unable to work from home, you may be eligible to claim the grant worth £500.

Cllr Tony Leech, West Devon Borough Council's Lead Member for health and wellbeing said: "These grants will help support people most at risk of financial hardship and provide a degree of security for those needing to self-isolate. There are a range of other measures that the Council may be able to offer households who are finding things difficult, so if you are experiencing difficulties, please make contact with us.

Cllr Jonathan Hawkins, South Hams District Council's Executive Member for health and wellbeing added: "It is looking like there is a challenge ahead of us all, we must help to control the COVID virus and stop it spreading. This payment will enable those people who would otherwise not be able to afford to self-isolate, protect others and play their part."

You can apply for the Test and Trace Support Payment of £500, if you meet the following criteria:

- You are over 16 and have been told to self-isolate by NHS Test and Trace on or after 28 September 2020.
- You are employed or self-employed.
- You cannot work from home and will lose income as a result.
- You are currently receiving at least one of the following benefits:
 - Universal Credit,
 - Working Tax Credit,
 - Income-based Employment and Support Allowance,
 - Income-based Jobseeker's Allowance,
 - Income Support,
 - Housing Benefit and/or
 - Pension Credit.

If you fail to comply with the Test and Trace isolation rules – not self-isolating following a positive test result for COVID-19, or if you are contacted by NHS Test and Trace and instructed to self-isolate because you are a contact of someone who has had a positive test result – you could face a fine. If you test positive for COVID-19, it will also be an offence to knowingly provide false information about your close contacts to NHS Test and Trace.

Failure to comply with these requirements may result in a fine of up to £10,000.

What is easyfundraising?

According to their website, Easyfundraising is 'a website and app that turns everyday shopping into free donations for your cause or charity'. They have 1.8m supporters who, by shopping with 4,100 retailers, raise money for 150,000 causes and charities. There are very few parish councils but their presence proves they are accepted.



Why should we launch an easyfundraising page for Dartmouth Town Council?

It is important that, as a town council and as a community, we encourage locals and visitors to support local businesses wherever possible. However, as online shopping is here to stay, it would be short-sighted not to consider whether our town could perhaps still benefit from this. Easyfundraising has 4000+ registered retailers and clearly our high street (or any other) cannot match this breadth, so I would propose that our message is essentially 'We would love for you to choose to support our local businesses here in Dartmouth but, if you are shopping online, please consider doing so with one of 4000+ retailers via our easyfundraising page. At no extra cost to you, Dartmouth Town Council will receive a donation which will be spent on a range of local projects to benefit our town'.

As with my proposal for the lottery, the revenue from easyfundraising would allow DTC to continue or enhance investment in various community projects aimed at improving the town and enhancing quality of life for the people of Dartmouth, perhaps including offering grants to local community groups or community events or contributing towards enhancing our town's visual appearance and facilities. Depending on how easy it is to update the wording for the cause on easyfundraising and to identify and contact supporters, I would propose to consider whether we can involve fundraisers in deciding how funds are ultimately spent. For example, supporters of the DTC Lottery chose the Defibrillators for Dartmouth project as their local good cause for 2020.

How would it work?

Registration is free of charge and appears to be simple and straightforward for both supporters and causes. There is an app (android and iOS) and webpage for shoppers. When a supporter shops through our webpage, the retailer pays easyfundraising a donation, generally 0.5% to 10% of the purchase. Some retailers, e.g. insurers and broadband, may pay a larger flat fee. The shopper does not pay any more for their shopping. Donations totalling £15 or more will be paid to us every 3 months via bank transfer (if funds total less than £15, they will remain in the account until the following quarter).

How can we promote it?

The look and feel of easyfundraising is similar to the SeaMoor lottery in terms of the marketing materials and support offered. Like the lottery, we can promote via DTC website / Facebook, posters on council notice boards, word of mouth, etc. Over time, through stories of funds raised and how they have been spent, plus potential coverage of local prize winners.

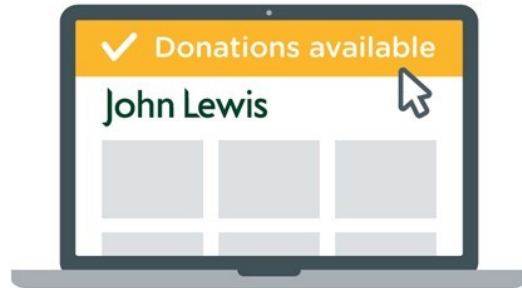
